Wanting to advertise on digital billboards September 15<sup>th</sup>-October 16<sup>th</sup>, Miriam will be reaching out for pricing. Spoke about the possibility of posting flyers at the YMCA, Boys and

Girls Clubs and like places to help spread the work along with social media and radio stations. Miriam also to reach out to Team Spirit about setting up a "shop" out at the fields to make and sell custom Midnight Madness shirts.
